### Review: Federal Law

Trafficking Victims Protection Act (TVPA)- passed in 2000


- Sex Trafficking- when commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such an act has not attained 18 years of age
- Labor Trafficking- the recruitment, harboring, transportation, provision, or obtaining of a person for labor or services, through the use of force, fraud or coercion for the purpose of subjection to involuntary servitude, peonage, debt bondage, or slavery.

### TIP- Labor Trafficking

- Labor Trafficking: subjected to involuntary servitudebeing compelled to perform labor or services for another against one's will
- · Ohio-specific stats:
  - Childcare/housekeeping
  - Sales crews that target young, vulnerable workers
    - · Some locals have reported additional crime- youth are not paid, so they steal food
  - Restaurants

### TIP- Sex Trafficking

Covers three different types of commercial sexual activity:

- · Sex for hire
  - Sexual activity for a thing of value (broader than just cash exchanging hands)
  - Drug use often seen- introduced by trafficker or intensified by trafficker
  - Minors can also be trafficked by parent or family member, or first trafficked by family member before going to a pimp

### TIP - Sex Trafficking

- Engage in a performance that is obscene, sexually oriented, or nudity oriented
- Defined by ORC 2929.01(DDD): "any performance that is obscene, that shows a person participating or engaging in sexual activity, masturbation, or bestiality, or that shows a person in a state of nudity"
- Consider: pornography, webcam sex, strip club

### TIP - Sex Trafficking

- Be a model or participant in the production of material that is obscene, sexually oriented, or nudity oriented
- Defined by ORC 2929.01(CCC): material that is obscene, that shows a person participating or engaging in sexual activity, masturbation, or bestiality, or that shows a person in a state of nudity
- Consider pornography

### TIP- Tiered System

- Tiered system of proof depending upon vulnerability of victim
  - Adults
  - Minors aged 16 and 17 years old
  - Minors under 16
  - Those with developmental disabilities

### TIP- Tiered System

- Adults: must prove that victim was "compelled" to engage in commercial sexual activity
  - Victim's will was overcome by force, fear, duress, intimidation, or fraud

### TIP- Tiered System

- Minors aged 16 and 17 years old: must prove that victim was "compelled" to engage in commercial sexual activity unless alleged trafficker is in a "position of authority" over the victim
  - Parent, guardian, someone acting in loco parentis
  - Teacher
  - Coach
  - Etc.

# TIP- Tiered System Minors under age 16: no need to prove compulsion, only that minor is engaged in commercial sex act Can't consent to sex → can't consent to commercial sex

### TIP- Tiered System

 Debate: why is Ohio's trafficking in persons law tiered based on the age of the minor when the federal law treats all minors as human trafficking victims?

### TIP- Tiered System

- Answer: AGE OF CONSENT!
- Ohio is in line with other states on issue:
  - 31 states have age 16 as age of consent
  - 11 states have age of consent of 18
  - 9 states are 17 and up

### TIP- Tiered System

- Those with a developmental disability: no need to prove that victim was compelled to engage in commercial sexual activity
- Person whose ability to resist or consent to an act is substantially impaired because of a mental or physical condition or because of advanced age
- Traffickers often target vulnerable individuals to traffic

### Unlawful Advertising of Massage

- Targets massage parlors that are fronts for illegal sexual activity and another outlet for sex traffickers
- New law prohibits advertising massage with the suggestion or promise of sexual activity
- 1st degree misdemeanor

# Commercial Sexual Exploitation of a Minor

- Designed to target ads that traffickers take out to advertise victims on websites
- New law prohibits knowingly purchasing or obtaining advertisement space for an advertisement for sexual activity for hire that includes the depiction of a minor
- 3<sup>rd</sup> degree felony

### Soliciting

- Applies to soliciting another person to engaging in sexual activity for hire
- Tiered penalties based on victim vulnerability:
  - Adult: 3<sup>rd</sup> degree misdemeanor
  - Minor aged 16 or 17 years old: 5th degree felony
  - Minor under age 16: 3<sup>rd</sup> degree felony
  - Person with DD: 3<sup>rd</sup> degree felony

### Soliciting

- Definition of DD same as in TIP statute
  - Person whose ability to resist or consent to an act is substantially impaired because of a mental or physical condition or because of advanced age
- Applies when the offender "knows or has reasonable cause to believe" that the other person is developmentally disabled

### Victim Protections

- Makes it easier to terminate parental rights when parents traffic their children
- CCTV for victims under 16 if judge determines one of the following:
  - Victim is unable to communicate about the alleged offense be of extreme fear or severe trauma
  - There is substantial likelihood that victim will suffer "serious emotional trauma" from testifying
  - Victim is at hospital for care and treatment for injury (physical, mental, or emotional) suffered by alleged offense

### Victim Protections

- Court can sentence a human trafficking victim to intervention in lieu of conviction if the victimization was a factor leading the offender's criminal behavior
  - Some ineligibility factors court would need to consider
- Expungement- victim can have prostitution-related charges expunged if she can show that she was a human trafficking victim
  - CATCH Court created document template

### Victim Protections

- Prohibits disclosure of police reports that are "highly likely" to identify minor arrestees who are also abuse victims (includes human trafficking victims)
- Exceptions: those who "need to know"- prosecutors, LE, DYS, probation officer, PCSA, parent, attorney, anyone under court order
